BUILDING A FUTURE WITHOUT GUN VIOLENCE: CHICAGO







70% of crime guns recovered in Chicago came from nearby gun dealers in Illinois, Indiana, and Wisconsin¹

DEMAND 2 DEALERS

DL2 dealers sell the most crime guns quickly used in crimes. From 2021 - 2023:

- 2% of dealers nationwide were part of the DL2 program.
- 37 Chicagoland dealers were in the DL2 program most for many years.
 - They supplied at least 2,225 crime guns recovered nationally from 2020 2022
- All of the top 10 suppliers of crime guns recovered in Chicago from 2013 2016 were still in the DL2 program in 2023.
 - These Chicagoland dealers supplied at least 6,190 guns recovered in Chicago crimes from 2009 2016²

GUN DEALER INSPECTIONS

- Chicagoland dealers were cited for more than 280 violations of federal gun laws from 2015-2018 yet only two of these dealers had their licenses revoked.3
- ATF inspections have become less frequent since the pandemic. ATF has only inspected 5% of dealers a year since 2020,4 less than a quarter of their goal of 33% annually.
- Even before 2020, ATF had only 17 gun dealer inspectors for the entire state of Illinois, meaning each inspector was in charge of overseeing more than 125 dealers.5

- Illinois State Police started inspecting gun dealers in 2019, but they so far have not revealed the results of their inspections.

FIREARM PROCUREMENT

- Taxpayers are the #1 buyer of firearms in America, spending more than \$5 billion on guns and ammunition for law enforcement agencies annually.
- Grassroots activists have successfully pushed San Francisco, Oakland, and San Diego to pass ordinances requiring their city governments only purchase firearms from dealers that have responsible business practices, follow the law, and sell few crime guns. On the state level, New Jersey led the way in instituting an executive order doing similar.7

KEY TERMS

"DEMAND LETTER 2" (DL2): A program created by the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) to identify firearms dealers that sell the most crime guns quickly recovered in crimes and to aid law enforcement investigations. To qualify, a dealer must have had at least 25 crime guns with low times-to-crime (less than 3 years) that were traced by law enforcement in the past year.

"TIME-TO-CRIME" (TTC): The amount of elapsed time between the retail sale of a firearm by a federal firearms licensee (aka dealer) and its recovery by law enforcement. ATF considers a time-to-crime of less than three years to be "low" and a potential indicator of trafficking.

"CHICAGOLAND": The Chicago Combined Statistical area, as defined by the U.S. Census. This includes areas of WI (largely Kenosha) and eastern IN.
